- » Tees, yardage markers, and sprinkler heads are measured to the center of the green
- » Repair all ball marks on greens
- » Replace divots
- » Replace flags
- » Keep golf carts 30 feet from all greens
- » Rake all footprints from sand bunkers
- » No more than two carts per foursome
- » No more than 3 minutes for lost ball search
- » No more than 4 players in a match
- » Appropriate golf attire required
